## **TERMS AND CONDITIONS FOR PARTICIPATION AT THE 2025 LAKESHORE BUSINESS LEADERS' SUMMIT**

The Malawi Confederation of Chambers of Commerce and Industry (MCCCI) annually organises the 2026 Lakeshore Business Leaders' Summit since the year 2022. The Business Leaders' Summit creates space for brainstorming on solutions to resolve challenges facing industry; provides a platform for collective lobbying and advocacy with policy makers present; creates a collective stage for charting the future of industrial ecosystem in Malawi that will withstand external shocks, and promotes networking amongst industry players. This is an annual event that is expected to attract members of the Private Sector and different stakeholders as participants. Delegates are therefore required to understand and comply with the Terms and Conditions for participation as contained hereunder:

### **1. APPLICATION FOR PARTICIPATION**

- a. All applications for reservation at the Lakeshore Business Leaders' Summit shall be made on the prescribed registration form issued by MCCCI.
- b. The completed application form shall be submitted together with proof of payment to MCCCI to qualify for booking optimally not later than 30th March 2026.
- c. On signature by MCCCI and the Applicant is in compliance with terms stated on the registration form, the document shall become binding contract between the parties.

### **2. METHOD OF PAYMENT**
